**Precautions for safe handling**

**Advice on safe handling** Avoid contact with skin, eyes and clothing. Eye protection or face shield should be used if material is used under conditions that increase the chances of splattering. If contact is made, wash skin with soap and water. Launder soiled clothing. Maximum handling temperature is 70 degrees C (158 F). It is recommended to pump or transfer material at ambient temperature.

**Storage Conditions** Keep away from heat and sources of ignition. Keep containers closed when not in use. Follow first aid measures if contact occurs, and spill procedures if spill occurs. For packaged material: Store in a cool dry area. For bulk material: store in cool dry area. Always follow local, state, and federal guidelines for storage of material for amount stored.
